- 110.3 Membership Reserve account are the funds directly collected as security deposits and membership fees. These funds are not to be used for any business activities and must be maintained as "refundable".





A budget is important because:


- Provides a pivotable plan





Water System Update

- KCWSC at maximum number of meters 82
 - Operating under a TCEQ Exception
 - TCEQ sets the allowed number of meters based on the Gallons-per-Minute-per-Connection
 - If a meter is removed from service there is no guarantee that it can be put back.
- Monitoring of Well Significantly Reduced
 - Pump output remains consistent but below rated capacity
- Meters replaced
 - New meters are digital (no moving parts)
 - Ability to review up to 96 days of use history at each meter
 - Water Loss is now down to just 4.38% (very low loss!)
- Storage Tank paint has been touched up
- Well House is in need of repair or replacement
- Electrical Power System will need to be reconfigured along with any well house work

Selling King Creek WSC

- Current Status
 - KCWSC separated relationship with KempSmith Law
 - Originally hired to help with contract negotiations and find prospective buyers
 - Performance was not productive and increasing charges and fees
 - KCWSC was refunded a portion of the retainer
 - KCWSC has contracted with WaterLogic Advisors, LLC
 - Consulting firm specializing in Water System sales
 - They are the direct interface with potential buyers interested in KCWSC
- Board Recommendation Sell KCWSC to Central States Water Resources (CSWR)
 - CSWR has submitted a non-binding Letter of Interest (LOI) to KCWSC
 - \$25,000 Cash payment
 - \$150,000 to be invested into the KCWSC system within the first 48 months of ownership
 - Proceeds from the sale will be divided among the current members of KCWSC
 - Divided in accordance with the By-Laws
 - Cash payment from sale, plus all bank accounts
 - Returns the neighborhood to being a neighborhood
 - Restores personal lives without burden of the water system
 - Removes liability from those serving on the Board of Directors
 - Eliminates the need for hours of work to learn the laws and regulations, maintain finances and compliances, deal with disgruntled customers
 - CSWR offers customer service than KCWSC
 - More payment options
 - More comprehensive website

Using the latest 13-month average customer usage of 3,131 gallons; KCWSC's bill would be approximately \$66.33 where as CSWR's bill would be approximately \$72.95. CSWR historically adjusts their rates on a 3-year cycle. CSWR rates are "consolidated" being that each system pays the same rates. This consolidation prevents the cost of one major issue in a small system from having to be exclusively carried by that small group of customers.
